

Mayor Smith said there was a grant to help provide the service, but the local match was \$100,000 to \$120,000. He further said Upper Cumberland Gas of Crossville had agreed to make the match. If this happens, then the City of Jamestown would lose the right to provide natural gas to the Highway 62 East area. After much discussion regarding the matter, on a motion by Gene Holt, seconded by Charles Cooper, the Board voted unanimously to provide the local Grant match to provide natural gas service to the Clarkrange Business Park.

In regard to running gas on Highway 62 East past the Clarkrange Business Park road, a study will be conducted to see if there is enough interest to make it feasible to run the line.

Discussion was then had regarding reducing the cost of the gas tap fee. Following the discussion, on a motion by Corwin Brown, seconded by Charles Cooper, the Board voted unanimously to table the matter until a special called meeting is held.

In regard to the request for gas service to the Grimsley Hills Subdivision, it was reported that a road bore would have to be made. Also, when the Gas Superintendent checked with the residents in the area, only three (3) said they would like the gas service. Therefore, on a motion by Ed Brady, seconded by Danny Hayes, the Board voted unanimously to defer action on the matter.

Discussion was then had regarding making Price Street a one-way street. On a motion by Danny Hayes, seconded by Corwin Brown, the Board voted unanimously to make Price Street one-way east from Reeder Avenue to Rugby Avenue.

The City has no policy regarding obtaining copies of public records. on a motion by Danny Hayes, seconded by Ed Brady, the Board voted unanimously to adopt the State of Tennessee guidelines dealing with requests for copies of public records, which sets the cost of copies at 15¢ per page, plus cost of labor for requests requiring large numbers of copies.

On a motion by Danny Hayes, seconded by Ed Brady, the Board passed on first reading Ordinance #1410, which replaces Ordinance #870 regarding OSHA standards and regulations.

On a motion by Corwin Brown, seconded by Charles Cooper, the ~~XXXXX~~ Board voted unanimously to adopt a credit cardholder policy which allows the City to obtain a credit card for use while traveling out of town for business purposes, with a card being issued to the Mayor, City Recorder, Chief of Police, and Public Works director.

On a motion by Ed Brady, seconded by Danny Hayes, the Board approved Resolution #885 which allows City employees to participate in two (2) new options offered by the Tennessee Deferred Compensation Retirement Plan.

On a motion by Danny Hayes, seconded by Gene Holt, the Board voted unanimously to update the utility service application form to require a driver's license number and social security number of the person requesting the service.

Since current Building Inspector Bob Lane is not under contract, on a motion by Ed Brady, seconded by Charles Cooper, the Board voted unanimously to release a Request for Qualifications (RFQ) form for the position of City Building Inspector using the MTAS form.

On a motion by Gene Holt, seconded by Danny Hayes, the Financial Statement was unanimously approved as read showing \$353,510.40 in the General Fund and \$3,559,332.17 in the Utility Funds, for a total of \$3,912,842.57.
